UPC note that sites 35,37,38 have been removed from the updated consultation document (19 pitches) but since these sites had no access to the road network via Small Lode it is difficult to see why they were included in F55. New road site PE14 9HP withdrawn.
GT18 Primrose Farm reduced from 16 to 12
All other points made in the previous response have been disregarded to date and UPC ask that where relevant following the reduction in the number of pitches they be taken into account.
UPC concerns remain over the expansion of sites GT17 The Lodge Small Lode and GT18 2 Primrose Farm. GT 17

received planning permission for an additional 4 plots in 2019 and further expansion of another 9 should be strictly reserved for family members.

Likewise GT18 2 Primrose Farm where there is currently permission for 4 plots, further expansion of another 12 for family needs should be scrutinised when planning permission is applied for to ensure that this is the case. Reference F95 sequential/exception test. Please note correspondence from the MLC re planning application 14/00029/F concerning surface water drainage and effluent disposal

Although previously referred to, the following extract from Proposed sites and policy consultation document May 2 F93 is significant:

7.7. Gypsy and Traveller sites may also need to have good access to the road network to accommodate the movement of larger vehicles associated with their livelihood, as well as their nomadic and traditional way of life. Small Lode is, in the main, a single carriageway and unsuitable for such vehicular movements.

Extracted from the New Policy: Sites for Gypsies, Travellers and Travelling Showpeople F93

- 2. Proposals for allocated and safeguarded Gypsy and Traveller sites, and/ or the extension and/ or intensification of such sites to address the needs, should, where appropriate:
- a) address an unmet need identified in the Gypsy and Traveller Accommodation Needs Assessment Update 2023, or any successor; and ensure that that need is genuine.
- b) in the case of an extension, be small scale, expansion of Gt18 is not small scale.
- g) have the ability to be well integrated into the local townscape or landscape, as previously stated: Visual appearance and intrusion into the landscape. GT17 and GT18 would be visible from many directions and impinge on the open fen landscape. The decision re 23/01606/F is relevant as is the following:

The Borough Council's Landscape Character Assessment states that key characteristics of the landscape include extensive vistas with wide open skies evoking a strong sense of openness, exposure and isolation. Landscape sensitivities identified include the sense of openness and remoteness within views across the area and a very strong sense of tranquillity throughout the area. The report sets out that the overall strategy for the fens should be to conserve the predominantly open strong geometric landscape pattern of arable fields. Landscape planning guidelines are to conserve the generally undeveloped, rural character of the area and strong sense of remoteness and tranquillity; conserve wide open views across the area; and seek to ensure that new small-scale development in the area is consistent with the settlement pattern.

The extent of the proposed sites accessed from Small Lode would be contrary to this. Far from a small scale development, development on this scale is not consistent with this statement.

Variation of Condition 3 of Appeal Decision APP/V2635/A/10/2139784 attached to planning application 10/00845/F to allow a further static caravan on site at Primrose Hill Small Lode U well

The Commissioners and associated Boards promote meaningful pre-application discussion, as encouraged in items 188192 of the NPPF, as this enables any issues to be dealt with prior to and not during the planning process and offers us, your authority and the applicant more certainty in the decision making process and can ensure that our limited resources are maximised and not wasted. It is noted that no pre-application discussion occurred on this occasion.

This site is within the catchment area of Churchfield and Plawfield Internal Drainage Board (IDB) and this planning response is written by the Middle Level Commissioners as engineering consultants to the Board.

The watercourse forming the north eastern boundary of the site is a Boards Drain and thus subject to its byelaws. From past experience it is known that ground conditions in this area are not conducive to the use of soakaways or other infiltration devices for surface water/treated effluent disposal unlikely to meet the requirements of BRE Digest 365 Soakaway Design, CIRIA C 697 - The SUDS Manual or other approved guidance and, therefore, if utilised may not provide an effective means of surface water/treated effluent disposal.

In the absence of any supporting documentation, it is considered that the applicant has not yet provided adequate evidence to prove that a viable scheme for a ro riate water level/flood risk mana ement that meets current desi n standards exists that it could be constructed and maintained for the lifetime of the develo ment. As you are aware the effective disposal of surface water is a material planning consideration, therefore, the applicant should be asked to clarify the method and location of surface water disposal devices.

The method and location of such systems can dictate the density and location of the proposal within the development

site.

The Board will expect the applicant to provide the Council with, and reserve the right under their byelaws to themselves require, adequate details and test results, where appropriate to prove that the proposed surface water/treated effluent disposal system will work efficiently at this location and effectively in the long term. Such information should include:

Confirmation of the design/analysis method used. Details of ground conditions, boreholes logs, land levels, water levels, etc.

Design calculations

Details of the proposed devices

In view of the above, it is considered that the following relevant items contained within your Council's policies and documents are relevant on this occasion (emphasis added by the Commissioners):

The Borough Council's SFRA - Annex to Level I [October 2010].

Norfolk County Council's emerging King's Lynn & West Norfolk Settlements Surface Water Management Plan. Any national advice in force at the time.

In addition to the requirements of the NPPF and associated

technical guide, all applications for relevant developments must include a drainage strategy to demonstrate that suitable consideration has been given to surface water drainage that appropriate arrangements for dealing with surface water run-off can be accommodated within the site, and that issues of ownership and maintenance are addressed.

The discharge of surface water from developments should be designed to contribute to an improvement in water quality in the receiving water course or aquifer in accordance with the objectives of the Water Framework Directive. All proposals should have regard to the guidance and byelaws of the relevant Internal Drainage Board. Further supporting evidence including, as a minimum, detailed engineering plans to an engineering scale, appropriate supporting calculations, a risk impact assessment and/or additional information, is required to prove to the Board that a viable scheme for appropriate water level/flood risk management exists, or that it could be constructed and maintained for the lifetime of the development with no material prejudice to the Board operations or the local water level management system, water or built environment should the development proceed. The above will be required from the applicant before further consideration can be given by the Board when seeking its consent for issues associated with this proposal. A copy of this letter has been sent to the applicant(s) agent(s). Your Council should refer to our 'Standard Advice relating to Development Management and Flood Risk Issues (April 2013)' which is available at http://www.middlelevel.gov.uWplanning-consentdocuments.aspx.
