- Appeals update (8 weeks to determine BGP; 6 months to appeal)

 - Biodiversity net gain GOV.UK (www.gov.uk)
- Council has invested in Software to monitor BNG (also links with CIL and S106 monitoring)
- Monitoring fees for BNG coming but not yet implemented
- Website updates (competent person for Small Sites Metric and FAQ document)
- Habitat Banks responsible body legal agreement option now available to providers. RSK acting in our area.
- Self build (heads of terms) heads of terms or condition will be required to confirm exemption
- Legal agreements required for significant onsite and offsite gain PAS templates available from
 the government which should require minimal legal input. Ask Planning Officer for these if
 required. Examples of legal agreements and BNG clauses also provided publically on PAS
 website: Enter a legal agreement for biodiversity net gain GOV.UK (www.gov.uk)
- Blue line land registration with Natural England is required and comes with a cost and must be secured legally. You may want to consider putting in red line boundary to avoid having to register it and if the gain is not significant then it will not need to be legally secured.
 Definition for on site significant BNG is on the gov website: Make on-site biodiversity gains as a developer GOV.UK (www.gov.uk)
- Accurate baseline is essential
- Lots of errors in how trees are being delt with by Users i.e. double counted, not recorded at all
 or recorded as retained with conflicts with arb reports in which they are removed

HWH – Confirmed that Heads of Terms where BNG is required to be secured by a legal agreement. Deemed condition will be dealt with via an informative. Such condition will need to be discharged via the usual form until further notice.

HM – Question can BNG be included within the blue line to offset BNG on an alternative site, i.e. Gaul Road, March (Suggested by JM). Also mentioned about how costly Ecologists are and with very few Ecologists available this is holding up planning applications being submitted.

NPPF

HM- New Government are consulting on revised NPPF - consultation is still open until 24th September.

A few changes were mentioned by HM that may affect Agents – i.e. Fee's, 5 Year Housing Supply, Green Belt (not relevant to Norfolk), Affordable housing. Helen will share all information to the group, RCA would likely share the NPPF consultation response on LinkedIn .

HWH- NPPF consultations also proposes increase in Planning fee's, National Scheme of Delegation.

Preapp fees may be increased. LPA has a meeting on 14th October to discuss PAS tool kit.

HM- Asked about planning Officers areas are they still split into North and South.

HM- Each team will be split into areas with opportunity to process applications within the north and south of the Borough.

SG – Asked about planning fees for PREAPPS said we were cheaper VS other Authorities.

HWH - confirmed that once we have had the PAS training on 14th October the fees will be revised, and Agents will be updated with the new working arrangements once finalised.

RR- Updated on the validation team introducing the newest member of the team Laura Renshaw, Validation team are all up to date in registering planning application to hope this to continue. Asked for CIL forms to be submitted with applications.

RR- reminded agents to ensure that the correct exemption or BNG are being selected on the application forms. All exemption information is available on the Borough Councils website.

HWH- updated on mobile working and new monitoring system called Exaicom coming in within the new few months.

RR- Update on Discharge team newest member Emma Grimmer dealing with application in the south and Julie Belding continuing her work within the North. When emaling the disc team please do not email individual officers please use the generic email address.
