Summary of Comments:

MM31 provides welcome clarification regarding the requirement for transport assessments and travel plans.

Of ongoing concern is whether the Borough's Transport network will have the capacity to support the spatial pattern of growth and whether it is too dependent on car travel (see MIQs 20-28). Further will the A149 within and beyond the KLTS area support visitor accessibility to Hunstanton and the Coast or will seasonal congestion act as a constraint on the tourist economy?

The transport evidence base shows that under all forecast scenarios there is significant congestion along the A149 within the modelled area and this modelling excluded seasonal tourist traffic and 'sugar beet campaign' HGVs.

The MMs to the Transportation Policy (LP13) aim to address some of these issues by proposing a scoping a study of the A149 corridor (MM32) identified in Para 5.7.14 and by

identifying the A149/Queen Elizabeth Way as a priority location for transport improvements (MM34).

To be effective the scope of the A149 corridor study should be extended northwards to include the seasonally, heavily congested section between Dersingham and Hunstanton. This is needed to identify the economic and social impacts (costs) of this congestion so that transport solutions can be found and implemented which protect and promote the Borough's tourist offering.

The commitment in MM32 to upgrade the KLTS is welcomed but the modelling framework – in addition to incorporating all modes of sustainable transport needs to cover the entire Borough – Kings Lynn can't stand in isolation.

Under the proposed modifications the plan lacks clear proposals for active travel infrastructure <u>directly linking</u> new housing in the proposed urban growth area, the railway station, employment, schools and shopping destinations in Hardwick and Kings Lynn. There is no indication of how such infrastructure might reduce numbers of vehicles on the road network and to what extent the predicted congestion could/would be reduced.

The LCWIPS study includes a route to Hardwick and King's Lynn but this route currently fails to meet national guidance and standards (hostile user environments, dangerous junctions, shared carriageways for pedestrians and cyclists and no effective provision for users with accessibility needs).

MM34 needs to demonstrate a clear commitment and approach (lines on maps and numbers) to reducing car dependence and building appropriate infrastructure to support and encourage active travel and how this could complement the WWHAR scheme in reducing congestion and emissions.

Whilst it is accepted that this would increase infrastructure costs it would nevertheless bring the Urban Growth Area transport proposals into line with national guidance and should increase the chances of winning government funding and wider community support.

With these small alterations it is considered that LP13 addresses the Transport issues raising questions of soundness. The success of the plan going forward would depend on the success of completing and implementing the proposed studies.
