REGISTER OF MEMBERS' DISCLOSABLE PECUNIARY INTERESTS

The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012

- (i) The Member's spouse or civil partner,

- (iii) A person with whom the Member is living as if they were civil partners,

and the Member is aware that the other person has the interest.

Members must give a description of the nature of the disclosable pecuniary interest and state whether it is their interest or an interest of a 'relevant person' described above, providing the name of the other person and the nature of their relationship to the Member.
