



<p>.....Ingoldismorpe.....</p> <p>Parish Council Register of Members' Interests</p> <p>Name: <u>TERENCE NEWLAND</u>.....</p> <p>These are the interests which you are required to register with the Authority by section 30 of the Localism Act 2011</p> <p>It is a breach of the Code and an offence to fail to disclose a registerable interest within 28 days of taking office with the Authority or within 28 days of declaring a new interest at a meeting.</p> <p>You must register your interests and interests of your spouse or civil partner or a person with whom you live as a spouse or civil partner.</p> <p>This form will be published on the Borough Council website.</p>		<p>Notes</p> <p>(a) Please state in full the names of any organisations referred to rather than use abbreviations or acronyms.</p> <p>(b) Please if possible type your responses.</p> <p>(c) Where there is no interest please write "NONE".</p> <p>(d) There is no need to register "sensitive information" provided the Authority's Monitoring Officer agrees. "Sensitive information" is information which, if made public, could lead to you or a person connected to you being subjected to violence or intimidation.</p>
<p>Employment</p>	<p>(a) Any employment, office, trade, profession or vocation. NONE</p>	<p>This includes membership of other public bodies, company directorships or trusteeships etc but only if you receive payment or other gain (including expenses) in return.</p>
<p>Sponsors</p>	<p>Names of people and organisations who pay or have paid or given a financial benefit towards:</p> <p>(i) my appointment with the Authority; or</p> <p>(ii) The expenses I incur in carrying out my duties for the Authority:</p> <p>NONE</p>	<p>This does not include expenses paid by the Authority but does include payment or financial benefit from a Trade Union.</p>
<p>Shareholdings</p>	<p>Names of any company or other body which has a place of business or owns land inParish Council's area and in which I have shares or other securities with a nominal value of more than £25,000 or are more than 1% of the total issued share capital or of any one class of share capital</p> <p>NONE</p>	


Contracts	<p>Contracts withParish Council's and myself (or spouse or partner) <u>or</u> a firm in which I (or my spouse or partner) is a business partner, <u>or</u> a company of which I (or my spouse or partner) am a director <u>or</u> a company or other body in which I (or my spouse or partner) has a shareholding as defined above</p> <p>NONE</p>	<p>List contracts which are for goods, services or works. Do not list contracts which have been completed.</p>
Land and Property	<p>Address or description of the following :</p> <p>(a) Premises in Parish Council's area which are owned or leased or in which there is another beneficial interest.</p> <p>(b) Premises let by the Authority to a firm or company in which I (or my spouse or partner) is a business partner or director or has a shareholding as defined above.</p> <p>(c)Parish Council's area in respect of which I have a licence to occupy for at least a calendar month.</p> <p>NONE</p>	<p>This is wide enough to include your houses, flats and moorings. It also includes land held in trust for you.</p> <p>If necessary, in order to clearly identify your land, a plan should be attached edging it in red.</p>
Lobby Groups	<p>I am a member of these groups which seek to influence public opinion or policy:</p> <p>NONE</p>	<p>These include:</p> <ul style="list-style-type: none"> • political parties • bodies such as Friends of the Earth, Countryside Alliance, etc (if applicable) • trade unions <p>These are not required by section 30 of the Act but please respond</p>


