

Parish Council Register of Members' Interests		
Name: <u>JANE ANGELA BARNETT</u> These are the interests which you are required to register with the Authority by section 30 of the Localism Act 2011 It is a breach of the Code and an offence to fail to disclose a registerable interest within 28 days of taking office with the Authority or within 28 days of declaring a new interest at a meeting. You must register your interests and interests of your spouse or civil partner or a person with whom you live as a spouse or civil partner. This form will be published on the Borough Council website.		(a) Please state in full the names of any organisations referred to rather than use abbreviations or acronyms. (b) Please if possible type your responses. (c) Where there is no interest please write "NONE". (d) There is no need to register "sensitive information" provided the Authority's Monitoring Officer agrees. "Sensitive information" is information which, if made public, could lead to you or a person connected to you being subjected to violence or intimidation.
